

PLUM AQUA SWIM CLUB ~ 2010 MEMBERSHIP INFORMATION

- **Family Membership:** A Family Membership shall be defined as a husband and/or wife and their unmarried children, or children under legal guardianship of the member who reside in the same household and who are (1) either under nineteen (19) years of age or (2) are under twenty-four (24) years of age and are enrolled as full-time students. All other family members are considered guests and appropriate guest fees will apply. *Family information that is not in conformity with the above description shall require approval from the Board of Directors (Board). All exceptions will require an annual letter of request to the Board with detailed information and documentation prior to March 1 of the current swimming year.*
- Family members, 19 to 24 years of age, will be required to submit one of the following: valid PA Driver's License or valid College ID. *All other forms of identification require Board approval.*
- A babysitter may be added to a Family Membership for an additional fee set by the Board.
- **Single Membership:** A Single Membership shall be defined as an individual who has attained the age of eighteen (18) years of age who does not meet the qualifications of the family membership. Only one person is permitted on the pass.
- **Trial Membership:** A Trial Membership is available to all those interested in trying the CLUB for one season. This membership may be purchased only once in a lifetime. If the member wishes to return the following season, a stock certificate purchase will be required to retain membership in the CLUB.
- **Surrender:** This option is for Active members holding a paid-up stock certificate prior to January 1, 2003. Please complete your name and current address on the renewal application, attach a letter of request to surrender your membership, and return both forms to the address listed below prior to March 1, 2010. Once your request is Board approved, you will be issued a number in the order in which it was received and be placed on the surrender list for repayment.
- **Swim-Off:** This option is for all Active members holding a paid-up stock certificate who are no longer interested in holding a membership in the CLUB. Your stock certificate value (\$300.00) will be applied as payment for your final swimming year dues. Any monetary difference between the value of the Stock and membership dues is the responsibility of the member. Please remit payment, completed renewal application, and letter of request to the Board prior to March 1, 2010.
- Guest Fees apply to all non-members. See Plum Aqua Club's Rules and Regulations/Guest Privileges.
- All membership submissions must include a completed application, payment and required documents for approval. If there is a question concerning a membership, the Membership Committee will contact you. If you do not hear anything by May 15, 2010, your membership has been approved.
- All members are required to follow the Rules and Regulations and Bylaws of Plum Aqua Club. You may download these documents from www.plumaqua.com or request to receive a copy with your membership pass.
- Family*/Single membership passes will be ready for pick up at the front gate on Opening Day, Sunday, May30, 2010. A signature will be required for our records. *A family member, 16 years of age or older, may pick up the family membership pass.
